

OFFICE OF ASSOCIATE VICE CHANCELLOR, OPERATIONS

The Office of Associate Vice Chancellor (AVC) for campus operations provides administrative and fiscal oversight of 12 auxiliary and service center units. The office integrates campus planning with business operations that contribute to providing a vibrant campus environment for all stakeholders. This includes negotiating with national vendors supporting campus agreements ranging from food services, campus pouring rights, general merchandise, and building contractors to name a few.

In addition, the AVC, Campus Operations is the primary university representative for all campus lease agreements. University departments work with the office to review and enact lease agreements on real property interests ranging from ATM space, parking, or storage space. The office reviews and approves all requests that affect campus owned/managed streets. Committee assignments make up additional responsibilities for the AVC, Campus Operations. These include the University Space Committee (USC), Traffic & Parking Authority (TPA) Committee, Facilities Fee Oversight Committee, Campus Master Plan Committee, and the Dining Services Advisory (DSA) Committee.

Finally, the AVC, Campus Operations serves as the Policy Group Liaison for UTK's Emergency Operation Center. This role facilitates communications between the Chancellor's Cabinet and members of the EOC during campus emergency events.
